- Novoceram products are involved in obtaining green certifications for buildings such as the commitment of the <u>Haute Qualité Environnementale</u> (High Environmental Quality) and the American <u>LEED</u> (Leadership in Energy and Environmental Design) certification. Novoceam is a member of the U.S. Green Building Council and the <u>HQE Association</u>, whose aim is to control the impact of a building on its environmental context and of promote a healthy and comfortable indoor living space. Finally, Novoceram has also commissioned the <u>PEF</u> (Environmental Performance Footprint) and <u>EPD</u> (Environmental Product Declaration) of its products, which indicate the potential environmental impact of a product along its entire life cycle. Our tiles are classified <u>A+</u>: the best level of this classification. Furthermore, being completely free of volatile organic compounds emissions, they even exceed the criteria required for classification A+.
